Minutes of the Meeting of the Empowered Committee of MAI held on 23.2.2018 to discuss proposals of EPCs and Trade Bodies for MAI assistance in 2018-19

The list of participants is annexed.

2. JS, MAI, DoC welcomed the participants. In a brief presentation made by him, it was highlighted that MDA Scheme ceased to be in operation from FY 2017-18 and the new merged MAI Scheme has been approved and circulated to all the concerned along with latest guidelines. He further informed that while approving the new Scheme, it has been stressed that clear outcomes of the MAI funding, in terms of participation from India, foreign buyers, business generated, orders booked, exports expected and achieved over a period of time, etc, need to be brought out. He further mentioned that the EPCs and Trade Bodies need to handhold exporters particularly from MSMEs and the weaker sections of the society. It was also mentioned that despite fund constraints, Department has decided to keep the level of export promotion activities in 2018-19 at the level of previous year.

3. With the permission of the Chair, proposals listed in the agenda were taken up one-by-one. The decisions taken by the EC on the agenda items are as under:

I. RBSM

- (i) RBSMs for Textiles Sector: It was noted that no proposal for Textiles India 2018 had been received. Funding for the Textiles RBSMs during 2018-19 has been restricted to the level of SC recommendation. No additional funding would be provided for the RBSMs in the Textiles Sector. Ministry of Textiles may consider alternate sources of funding for any additional requirement for Textiles India, 2018.
- (ii) RBSMs in Agri Sector: The proposals of APEDA for organising RBSM in Mumbai and Biofach India were approved. APEDA has, however, been directed to create a separate vertical for Organic Food in Indus Food, 2019. As regards the proposal of TPCI for additional funding for Indus

Food 2019, increase in funding proportionate to the increase in number of foreign buyers was approved.

- (iii) CAP INDIA: The Chair observed that the four Councils (Chemexcil, Plastic EPC, Capexil and Shefexil) organising CAP India were not putting adequate collective efforts for successful organisation of the event. It was decided that though for accounting purposes, MAI funding would be given to one Council, all four Councils will be equally responsible for organising the event.
- (iv) Advantage Healthcare India: Share of space and funding to FICCI and SEPC would be proportionate to the level of participation of each Agency. Services Division would work out details in this regard.
- (v) Global Exhibition on Services: It was noted that this was a special flagship event in Services Sector and keeping in view the status of the event, MAI assistance of Rs.12.70 crore was approved. It was also noted that "Investment" vertical would be included in GES 2018.
- (vi) Higher Education Summit: SEPC would join FICCI in the event. "Study India" would also join this event, for which a separate proposal may be moved.
- (vii) State-specific events: EC observed that it would be difficult to accommodate State-specific proposals within the allocation made for the Scheme. In principle, EC did not approve the proposals moved by FICCI for Vastra, 2018 and Stonemart, 2019. EC observed that unless additional financial allocation was received under MAI Scheme and there were surplus allottable funds after meeting the requirements of the other RBSPMs, would such proposals be processed.
- (viii) Inviting Buyers from Developed Countries: EC reiterated that while EPCs may continue to invite Buyers from Developed Countries, MAI funding would continue to be restricted for hosting buyers from other regions.

Subject to above observations, EC approved the RBSM proposals listed in the agenda.

II. Events Abroad

- (i) EC noted that there was considerable increase in the number of proposals as well as funding proposed for Europe and NAFTA, particularly in Textiles and Handloom & Handicrafts sectors. It was decided to refer back the proposals of Textiles Sector for these two regions to Ministry of Textiles for rationalisation. (ANNEXURE L).
- (ii) EC also observed that instead of concentrating on European and North-American markets, EPCs and Trade Bodies should explore other markets.
- (iii) EC decided that the proposal of TPCI to establish Trade Centre in Moscow will be considered separately, after a thorough scrutiny by FT (CIS) and EP (Agri) Division and their subsequent recommendations or otherwise.
- (iv) EC felt that majority of proposals by Services EPC (SEPC) was about taking delegations abroad. It was felt that SEPC should instead participate in established fairs/events of international repute. EC decided that Services Division would re-examine the delegations proposed by Services EPC and instead recommend its participation in established fairs abroad.
- (v) The request of EEPC and ICC to increase funding for Dubai events was accepted and it was decided to increase it to the level of 2017-18.
- (vi) Due to non-availability of space, ITPO and APEDA dropped the proposal for SIAL Food, Canada.
- (vii) EC felt that it was not necessary for APEDA to organise Mango Promotion event at USA and Cashew EPC regarding marketing and promotion of cashew. It was decided that APEDA will partner with ASSOCHAM in VIETFOOD & Beverage, Vietnam and Services EPC will partner with FICCI in MEDEX, 2018.

- (viii) The agencies would ensure quality of participants and also ensure return of participants after attending the events.

Subject to above observations, EC approved proposals listed in the agenda for events abroad.

- III. **Proposals for ex-post-facto approval:** EC noted that these proposals have been approved on file by IFD and CS and accordingly, approved the proposals placed for ex-post-facto approval.
